ORDER CANCELING CERTIFICATES
AND ACCOMPANYING TARIFFS

Issue Date: April 19, 2006

Effective Date: April 29, 2006

On April 14, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificates of service authority and accompanying tariffs of ICG Telecom Group, Inc., a company that has been authorized by the Commission to offer basic local telecommunications services and as well as intrastate interexchange and non-switched local exchange telecommunications services in Missouri.

In Case Number TA-98-577, the Commission granted ICG a certificate to provide intrastate interexchange and non-switched local exchange telecommunications services. ICG's tariff, MO PSC No. 1, was also approved.

In Case Number TA-98-589, the Commission granted ICG a certificate to provide basic local telecommunications services. ICG's tariff, Mo PSC No. 2, was also approved.

Staff's motion states that ICG indicated in its confidential Statement of Revenue and correspondence that it is no longer in business. Furthermore, ICG informed Staff it had no Missouri jurisdictional revenue and no longer wished to maintain its operating certificate in Missouri. Staff recommends that the Commission cancel the company's certificates of service authority and accompanying tariff, MO PSC No. 1, to provide intrastate interexchange and non-switched local exchange telecommunications services in Missouri, and ICG's certificate and accompanying tariff, Mo PSC No. 2, to provide basic local telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and ICG's request to cancel the certificates and tariffs included in its Statement of Review and correspondence from its operator, the Commission finds that the certificates of service authority and accompanying tariffs granted to ICG Telecom Group, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificates of authority to provide intrastate interexchange and non-switched local exchange telecommunications services and basic local telecommunications services granted to ICG Telecom Group, Inc., in Case Numbers TA-98-577 and TA-98-589 are canceled.

2. ICG Telecom Group, Inc.'s tariff, Mo PSC No. 1, is canceled.
3. ICG Telecom Group, Inc.'s tariff, Mo PSC No. 2, is canceled.
4. This order shall become effective on April 29, 2006.
5. This case may be closed on April 30, 2006.
