ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: October 23, 2017

Effective Date: November 2, 2017

On September 21, 2017, NECC Telecom, Inc. ("NECC") filed notice that it was discontinuing services and asked the Commission to cancel its certificate of service authority and accompanying tariff to provide telecommunications services in the State of Missouri.

In File Number XA-2003-0068, the Commission granted NECC a certificate of service authority to provide telecommunications services in the State of Missouri, and approved its tariff. Specifically NECC was approved to provide interexchange telecommunications services. The Company's tariff, P.S.C. MO No. 1 was also approved.

On September 26, 2017, the Commission issued an Order Directing Staff to File a Recommendation. On October 10, 2017, Staff filed its recommendation and stated that NECC no longer wished to retain its certification to provide interexchange telecommunications services in Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide telecommunications services and the company's accompanying tariff.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on NECC’s request and Staff’s recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to NECC Telecom, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to NECC Telecom, Inc., in File Number XA-2003-0068, is canceled.
2. NECC Telecom, Inc.’s tariff, P.S.C. MO No. 1 is canceled.
3. This order shall become effective on November 2, 2017.
4. This case may be closed on November 3, 2017.


