**ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE,
AND SCHEDULING A PROCEDURAL CONFERENCE**

On October 22, 2018, Union Electric Company d/b/a Ameren Missouri filed an application with the Missouri Public Service Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) pursuant to section 393.170, RSMo 2016. The CCN would authorize Ameren Missouri to construct, own, and operate a wind generation facility to be constructed in Atchison County in Missouri. Ameren Missouri requests the Commission grant it a CCN no later than May 1, 2019.

The Commission will provide notice of the application to the general public and interested parties and set a deadline for intervention requests. If no movant is granted intervention, and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary for a determination of the application.¹ In addition, the Commission will schedule a procedural conference for November 6. The Commission will take up the procedural schedule proposed by Ameren Missouri as well as the company's motion for a

protective order at the conference.²

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the County Commission of Atchison County, Missouri.

2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing Atchison County, Missouri and to the media serving that county.

3. The Commission's data center shall provide a copy of this order to each party to Union Electric Company d/b/a Ameren Missouri's triennial IRP filing in File No. EO-2018-0038, and to each party in File No. EA-2018-0202, the case established to consider Ameren Missouri's application for a certificate of convenience and necessity regarding the proposed High Prairie wind generation facility.

4. Any person wishing to intervene in this matter shall file an application to intervene no later than November 2, 2018. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission.

5. A procedural conference is scheduled for November 6, 2018, beginning at 10:00 a.m. The conference will be held at the Commission's office at the Governor Office Building, Room 305, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in this conference, may call




