SECTION 3 - DESCRIPTION OF SERVICES AND RATES, (CONT'D.)

3.64 CenturyTel SBS II Plan

CenturyTel SBS II plan is a flat rate product for 1+ and for 800 switched and 1+ and 800 dedicated service. The rates are based on the customers= monthly minutes of use. It also permits termination of intrastate calls from diverse geographic locations to the Customer's local exchange lines. Calls are billed in six (6) second increments with an initial period, for billing purposes, of thirty (30) seconds.

Additionally, the Customer will be billed Local Loop Installation and monthly recurring charges (on a pass-through basis) in the event that the Local Loop Charges are billed to CenturyTel Long Distance, LLC, as agent for the Customer.
