**ORDER APPROVING TARIFF AND GRANTING MOTION  
FOR EXPEDITED TREATMENT**

Issue Date: December 22, 2021

Effective Date: December 28, 2021

On December 15, 2021, the Commission issued its order granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) water and sewer certificates of convenience and necessity (CCNs). The Commission's order directed Confluence Rivers to file tariff sheets conforming to the Commission's order prior to closing on the assets of the various water and sewer systems. On December 16, 2021, Confluence Rivers filed tariff sheets to comply with the Commission's order along with a motion for expedited treatment. The Commission directed its Staff (Staff) to file a recommendation about the compliance tariff sheets no later than December 21, 2021. The Commission also set a deadline of December 21, 2021, for any other responses to Confluence Rivers' motion for expedited treatment or compliance tariff sheets. Staff filed a statement advising that the tariff sheets comply with the Commission's order. No other responses were received.

Confluence Rivers' compliance tariff sheets bear an effective date of January 15, 2022, but Confluence Rivers filed a motion for expedited treatment asking the Commission to approve the compliance tariff sheets to take effect on December 28, 2021, prior to closing of the purchase of assets for Cedar Green, Clemstone, The Missing Well, and Spring Branch. Prairie Heights and Shelton Estates have a later closing date and are not included in this motion for expedited treatment. This order does not approve compliance tariff filings for Prairie Heights and Shelton Estates.<sup>1</sup>

The Commission has reviewed the compliance tariff sheets and Staff's recommendation and finds that the tariff sheets should be approved. The Commission has also reviewed the motion for expedited treatment and finds that good cause exists under Section 393.140(11), RSMo, to expedite the effective date of the tariff sheets to meet the Commission's order granting Confluence Rivers' CCNs. The Commission will approve Confluence Rivers' compliance tariff sheets to become effective on December 28, 2021. In addition, the Commission will exercise its discretion under Section 386.490.2, RSMo, to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff sheets.

**THE COMMISSION ORDERS THAT:**

1. Confluence Rivers' motion for expedited treatment is granted.
2. The following tariff sheets filed by Confluence Rivers and assigned Tariff Nos. YW-2022-0183, YS-2022-0184, YW-2022-0185,<sup>2</sup> and YS-2022-0186, are approved to become effective on December 28, 2021:
