On April 17, 2015 Laclede Gas Company ("Company") filed <u>P.S.C. MO. No. 5 Consolidated, Twenty-Fourth Revised Sheet No. 12</u> to change the Infrastructure System Replacement Surcharge ("ISRS") applicable to the Laclede Gas operating unit of the Company. Subsequently, on May 12, 2015, the Company filed a substitute tariff sheet to reflect the ISRS rates in Appendix B of the memorandum that the Staff of the Commission ("Staff") filed on May 1, 2015. However, later on May 12, 2015 the Company voluntarily suspended the effective date of such tariff sheet to May 22, 2015 pending review of the tariff sheet by the Office of the Pubic Counsel. As a result of such review, along with the agreement of the Staff, the Company has made some further revisions to the ISRS rates that are reflected in the enclosed tariff sheet, which has an issue date of May 18, 2015 and an effective date of June 17, 2015. However, the Company requests that the Commission approve such sheet to be effective on May 22, 2015, consistent with the Company's *Renewed Motion For Expedited Treatment* that was also filed today.

As proposed herein, the increase in the ISRS would increase the typical residential heating customer's bill by 65 cents per month or less than 1%.

Please bring this filing to the attention of the appropriate Commission personnel.

On April 17, 2015 Laclede Gas Company ("Company") filed <u>P.S.C. MO. No. 5 Consolidated, Twenty-</u> <u>Fourth Revised Sheet No. 12</u> to change the Infrastructure System Replacement Surcharge ("ISRS") applicable to the Laclede Gas operating unit of the Company. Subsequently, on May 1, 2015, the Staff of the Commission submitted a memorandum recommending that the Commission issue an order in this case authorizing "Laclede to file an ISRS rate for each customer class as reflected in Appendix B" of such memorandum. The ISRS rates reflected in the aforementioned tariff sheet are identical to the rates in Staff's Appendix B with the exception of the rate for Vehicular Fuel. Accordingly, the Company has revised the attached Sheet No. 12 to reflect the ISRS rates recommended by Staff, including Vehicular Fuel, and respectfully requests that the Commission substitute such tariff sheet for the corresponding sheet the Company filed on April 17.
