I am providing herewith to the Missouri Public Service Commission for filing, in electronic form, the following revised tariff sheets:

These revised tariff sheets, which have an issue date of February 28, 2020, and an effective date of April 1, 2020, are designed to reflect the October adjustment made pursuant to the Company's Weather Normalization Adjustment Rider ("WNAR") for the six month period ending December 2019. The WNAR adjustment is \$0.01824 for residential customers in the Company's Northeast and West Districts, \$0.05165 for residential customers in the Company's Southeast District, \$0.00780 for small general service customers in the Northeast and West Districts, and \$0.01759 for small general service customers in the Southeast District. The rates are calculated semiannually to adjust for actual heating degree days as they differ from the normal levels and are effective for twelve months.

The Company's WNAR tariff states that the Company shall determine the Semiannual Reconciliation Rate ("SRR") based on the over- or under-billing during the twelve month billing of each Current Semiannual WNA ("CSWNA") and SRR using the effective CSWNA and SRR rates and nine months actual sales and three months projected sales. This filing includes the Company's initial CSWNA reconciliation for the twelve month period ending March 30, 2020. This CSWNA reconciliation establishes the initial SRR rates to be effective April 1, 2020. The SRR adjustment is \$0.00968 for residential customers in the Company's Northeast and West Districts, (\$0.00324) for residential customers in the Company's Southeast District, \$0.00538 for small general service

customers in the Northeast and West Districts, and \$0.00062 for small general service customers in the Southeast District.

Compared to currently existing rates, and assuming normal usage, the WNAR adjustment would increase the average monthly bill of the typical residential customer by approximately:

\$2.27 per month, or 3.77% in the Company's Northwest District;
\$2.10 per month, or 3.89% in the Company's West District; and
\$1.21 per month, or 2.59% in the Company's Southeast District.

Such bill impacts may be less or more depending on a customer's actual usage, which is primarily affected by weather.

Please bring this filing to the attention of the Commissioners and the appropriate Commission personnel. Redlined tariff sheets have been provided to Staff.
