## ORDER GRANTING LEAVE TO APPEAR *PRO HAC VICE*

On July 7, 2022, Albert Sturtevant filed a motion for leave to appear *pro hac vice* as an attorney for the Union Electric Company d/b/a Ameren Missouri.

Mr. Sturtevant states that he is an attorney at Whitt Sturtevant, LLP, in Chicago, Illinois. Mr. Sturtevant is not admitted to practice before the courts in Missouri but is a member in good standing of the Bar of the State of Illinois. He states he is not under suspension or disbarment and is not disqualified to appear in any jurisdiction.

Mr. Sturtevant states that he is associated with James Lowery, a member in good standing of the Missouri Bar, who has previously entered his appearance on behalf of Ameren Missouri. Mr. Sturtevant also filed proof of his compliance with Missouri Supreme Court Rule 6.01(m).

The Commission has considered the motion and finds that Mr. Sturtevant complies with the requirements of 20 CSR 4240-2.040(3)(C) and Missouri Supreme Court Rules 6.01(m) and 9.03. The Commission therefore admits Mr. Sturtevant *pro hac vice*.

1. The motion for leave to appear *pro hac vice* filed by Albert Sturtevant to appear on behalf of Ameren Missouri is granted.
