ORDER APPROVING INTERIM TARIFF

Issue Date: October 20, 2021

Effective Date: November 1, 2021

On September 15, 2021, the Commission issued its *Order Rejecting Tariff to Change Fuel Adjustment Rates*. The Commission rejected Evergy Metro, Inc. d/b/a Evergy Missouri Metro's proposed tariff sheet (Tariff No. JE-2022-0024) to adjust its Fuel Adjustment Rates. On September 30, 2021, Evergy Missouri Metro filed a revised tariff sheet (Tariff No. JE-2022-0066) to implement interim fuel adjustment rates consistent with uncontested components of its proposed rate adjustment, as allowed by 20 CSR 4240-20.090(8)(H). The proposed interim tariff sheet bears an effective date of November 1, 2021.

The Commission ordered that any responses to the interim tariff sheet be filed no later than October 11, 2021. On October 6, 2021, the Office of the Public Counsel (OPC) filed a response indicating that it did not oppose the rates contained in the interim tariff, but expressed concern that there are no FAC tariff provisions that could legally apply to October 2021. OPC asked that the Commission make the interim tariff effective as quickly as possible. Evergy Missouri Metro replied that "any adjustment needed as a result of the

one-month delay in the effective date of the interim tariffs will be addressed in the true-up.” The Commission will approve the interim tariff. The effective date of the proposed interim tariff is November 1, 2021. Therefore, the Commission’s order will be effective in fewer than 30 days.

THE COMMISSION ORDERS THAT:

1. The following revised tariff sheet, filed in this matter by Evergy Missouri Metro and assigned Tariff No. JE-2022-0066, is approved, effective November 1, 2021:
