ORDER SETTING PARTIAL PROCEDURAL SCHEDULE

On August 18, 2022, Evergy Missouri West (EMW), Inc. filed an application with the Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) pursuant to Sections 393.170.2 and 393.190.1, RSMo, and Commission Rule 20 CSR 4240-20.045. The requested CCN would authorize EMW to operate, manage, maintain, and control an existing and operational wind generation facility in Woodward, Ellis, and Dewey Counties (near the town of Vici) in Oklahoma known as Persimmon Creek Wind Farm.

On November 23, 2022, the Staff of the Commission filed a motion to adopt a proposed procedural schedule in lieu of filing a recommendation. Staff stated that EMW was in agreement with its proposal and on November 29, 2022, EMW filed a separate response indicating its agreement. The first proposed procedural date is for the filing of Supplemental Direct Testimony on December 9, 2022. Since that deadline is near and EMW does not object to it, the Commission will set that portion of the procedural schedule while it considers the remaining dates.

THE COMMISSION ORDERS THAT:

1. Supplemental Direct Testimony shall be filed no later than December 9, 2022.
2. This order is effective when issued.
