## ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: June 8, 2017

Effective Date: June 30, 2017

The Commission issued a *Report and Order* on May 9, 2018, approving a rate increase for Gascony Water Company, Inc. ("Gascony"). On May 22, 2018, Gascony filed compliance tariffs pursuant to the May 22, 2018, *Report and Order*. Tariff No. YW-2018-0159 has an effective date of June 30, 2018. On May 23, 2018, the Commission set a deadline of June 4, 2018, for the Staff of the Missouri Public Service Commission to file a report on Gascony's compliance tariffs, and a deadline of June 7, 2018, for any other recommendations to be filed.

On June 4, 2018, the Staff of the Missouri Public Service Commission filed its recommendation to approve the tariff sheet. Staff stated that it had reviewed the tariff filing and found it to be in compliance with the Commission's order. No other responses were received.

After reviewing the tariff sheet and the Staff recommendation, the Commission finds that Gascony's tariff sheets comply with the Commission's *Report and Order* and will approve it.

**THE COMMISSION ORDERS THAT:**

1. The following tariff sheet, bearing Tariff No. YW-2018-0159, filed on May 22, 2018, by Gascony Water Company, Inc. is approved to become effective on June 30, 2018:

3. This order shall become effective on June 30, 2018.
4. This case shall close on July 2, 2018.
