ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH COMMISSION ORDER

On August 31, 2017, Missouri-American Water Company filed tariff sheets in compliance with the Commission's *Order Granting Certificates of Convenience and Necessity and Granting Waiver* issued on July 20, 2017. The submitted tariff sheets bear a proposed effective date of September 30, 2017, but the company has requested expedited treatment so the tariff sheets become effective on the date of closing, which is September 18, 2017.

On September 6, 2017, the Commission's Staff filed a recommendation that the Commission approve the compliance tariffs and grant the motion for expedited treatment. No other party filed a response or objected to approving the tariff sheets or granting the motion. The Commission has reviewed the tariff filings and Staff's recommendation and concludes that the tariffs should be approved and the unopposed motion for expedited treatment should be granted.

THE COMMISSION ORDERS THAT:

1. Missouri-American Water Company's *Motion for Expedited Treatment* filed on August 31, 2017, is granted.
