# ORDER APPROVING TARIFFS

Issue Date: July 21, 2022 Effective Date: August 13, 2022

On June 23, 2022, the Commission issued its Report and Order (Order). That Order authorized The Empire District Gas Company (Empire Gas) to file tariffs that comply with the Order. Those tariffs would allow Empire Gas to collect an additional \$1 million of annual revenue.

On July 7, 2022, Empire Gas filed Tariff Tracking No. YG-2023-0008. Empire Gas withdrew, substituted, and refiled the tariff sheets in Tariff Tracking Nos. YG-2023-0008 and YG-2023-0009 on July 14, 2022. Empire Gas noted in its accompanying transmittal letter that the substitutes and refiling reflected input it received from Staff.

On July 18, 2022, Staff filed its Recommendation. Staff stated that it reviewed the tariff sheets filed in Tariff Tracking No. YG-2023-0008, as substituted on July 14, 2022, and as filed in Tariff Tracking No. YG-2023-0009. Staff recommends the Commission approve them or allow them to go into effect. The Commission received no other responses to the tariff filing or Staff's Recommendation.

The Commission reviewed the tariff filings and Staff's Recommendation, and determines that the filings comply with the Commission's order.

# THE COMMISSION ORDERS THAT:

- 1. The tariff sheets in Tariff No. YG-2023-0008, issued July 7, 2022, as substituted on July 14, 2022, and the tariff sheets in Tariff No. YG-2023-0009, issued on July 14, 2022, are hereby approved to become effective on August 13, 2022.
  - 2. This order shall be effective on August 13, 2022.
