**ORDER APPROVING COMPLIANCE TARIFF**

Summit Natural Gas of Missouri, Inc. (Summit) submitted tariff sheets to comply with the Commission's April 13, 2017 order granting the company's amended application for a certificate of public convenience and necessity. The tariff sheets were assigned Tracking Number: YG-2017-0237. Summit extended the effective date for its tariff sheets from June 11 to June 30, 2017. The Commission issued an order setting a June 19, 2017 deadline for parties to file recommendations or objections to Summit's tariff sheets.

On June 9 and June 13, 2017, Summit submitted substitute tariff sheets to correct errors identified by the Staff of the Missouri Public Service Commission. On June 19, Staff filed a Recommendation stating Summit's substitute tariff sheets correctly represent Summit's prior tariffed territory, as well as the Commission-approved expanded territory. Staff recommends the Commission approved the tariff sheets that were most recently substituted on June 13, 2017. No other recommendations or objections were filed.

Finding the tariff sheets to be in compliance with the Commission's order issued on April 13, 2017, the Commission will approve the tariff sheets to go into effect on June 30, 2017.
