ORDER APPROVING TARIFF

KCP&L Greater Missouri Operations Company (GMO) filed a revised tariff on March 31, 2017, to adjust its Renewable Energy Standard Rate Adjustment Mechanism (RESRAM) rates. GMO's tariff revision carries a June 1, 2017 effective date.

The Commission's Staff filed a recommendation regarding GMO's tariff on May 12, 2017. Staff explains that the revised tariff appropriately removes the RESRAM Offset Adjustment that was applicable for the period of December 2016 through May 2017. Staff recommends the Commission either approve the tariff, or allow it to go into effect by operation of law. The Commission will approve the tariff.

THE COMMISSION ORDERS THAT:

1. The tariff sheet submitted under Tariff Nos. YE-2017-0190 by KCP&L Greater Missouri Operations Company is approved, effective on and after June 1, 2017. The specific tariff sheet approved is:
