The purpose of this filing is to increase rates by \$2.00 for Home Phone, Full House, and Small Business bundled services for residential and business customers. This filing also increases the rate of the Voice Advantage and ExpansionPAK II (EPAK II) In-State calling plans by \$2.00.

There are two sets of rates published for Small Business bundles. Customers with current term agreements will not see an increase in their rates until the expiration of their current term. Once their term expires, they will be subject to the rates, terms, and conditions of this filing for any services ordered on or after the effective date of December 16, 2015.


Also, there are two sets of rates published for EPAK II In-State Calling Plan for Unlimited Dialtone and EPAK II In-State Calling Plan for Unlimited Centrex. Customers with current term agreements will not see an increase in their rates until the expiration of their current term. Once their term expires, they will be subject to the rates, terms, and conditions of this filing for any services ordered on or after the effective date of December 16, 2015.

The month-to-month option rate for EPAK II In-State Calling Plan for Unlimited Centrex was revised to reflect the correct rate of \$5.50 (\$3.50 plus the \$2.00 increase). We have been billing customers correctly so the only change affecting customers is the \$2.00 increase.

Finally, in this filing we deleted the Home Phone 150 Plus bundle and all Home Phone bundles with the Calling Feature upgrade. There are no customers subscribed to any of these obsolete bundles and they are not being offered to new customers.
