Mr. Woodruff:

On April 15, 2021, Evergy Missouri West, Inc. d/b/a Evergy Missouri West – For St. Joseph, Missouri and Environs, filed a proposed rate schedule to adjust charges related to Quarterly Cost Adjustment (“QCA”). The Company is making this substitute tariff filing due to a reduction in March 2021 fuel costs that was not known at the time of the original filing.
