ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 16, 2016

Effective Date: August 26, 2016

On July 26, 2016, Davidson Telecom, LLC (“Davidson”) filed a notice of surrender of its certificate of service authority and accompanying tariff to provide intrastate interexchange and non-switched local telecommunications services.

In File Number XA-2003-0310, the Commission granted Davidson a certificate of service authority to provide intrastate interexchange and non-switched local telecommunications services in the state of Missouri. Davidson’s tariff, PSC MO No. 1, was also approved.

On July 29, 2016, the Commission issued an Order Directing Staff to File a Recommendation. On August 5, 2016, the Staff of the Commission filed its Staff Recommendation and recommended the Commission cancel Davidson’s certificate of service authority and tariff.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Davidson's request and Staff's recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to Davidson shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide private pay telecommunications services granted to Davidson Telecom, LLC, in Case Number XA-2003-0310, is canceled.
2. Davison Telecom, LLC's tariff, PSC MO No. 1, is canceled.
2. This order shall be effective on August 26, 2016.
3. This case may be closed on August 27, 2016.
