## ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: January 21, 2022

Effective Date: February 1, 2022

On December 8, 2021, The Commission issued its *Order Approving Stipulation and Agreement, Asset Transfer, and Certificates of Convenience and Necessity* (Order), granting Liberty Utilities (Missouri Water) d/b/a Liberty Utilities (Liberty) certificates of convenience and necessity for the Bolivar water and sewer assets. The Commission ordered Liberty to submit tariff sheets, to become effective before closing. On December 31, 2021, Liberty filed proposed tariff sheets for the water and sewer assets bearing effective dates of February 1, 2022. On January 19, 2022, Liberty filed proposed substitute tariff sheets in both the water and sewer cases to correct minor issues. The substituted tariff sheets are the cover page (“Title Page”) and the index (“Sheet No. 1”) for both the water and sewer tariff assets.

On January 20, 2022, Staff filed its recommendation to approve the tariff sheets. No other responses to the tariff sheets were received. Staff stated that it had reviewed the tariff filings and found them to be in compliance with the Commission’s order.

After reviewing the tariff sheets and the Staff recommendation, the Commission finds that Liberty's tariff sheets comply with the Commission's order and will approve them. So that this order can be effective along with the tariffs, the Commission finds it reasonable to make this order effective in less than thirty days.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets, identified as Tracking Nos. YW-2022-0195 and YS-2022-0196, are approved to become effective on February 1, 2022. The tariffs approved are:
