Subject: Staff Recommendation to Approve a Request to Override a Decision of the North American Numbering Plan Administrator

Date: December 3, 2009

Summary

On November 24, 2009, TCG filed a request to review and reverse a decision of the North American Numbering Plan Administrator (Pooling Administrator) for 1 block of one-thousand telephone numbers in the Chesterfield rate center. Specifically, Midland States Bank (Midland) requests 100 consecutive telephone numbers in the 636 NPA within any XXXX range other than 0XXX, 18XX, 22XX, 23XX, 32XX, 42XX, 51XX, 62XX, 71XX, 72XX, 73XX, 75XX, 85XX, and 9XXX its new Cisco IP Telephony direct inward dial (DID) system. Midland's new DID system includes 15 branch banks which has certain technical restrictions that exist which does not allow Midland to use certain blocks. Included in this filing is the Thousands-Blocks Application Form – Part 1 A (Part 1), a letter from TCG, Pooling Administrator's Response/Confirmation – Part 3 Form (Part 3), Months to Exhaust Utilization Certification Worksheet, and TCG's Number Utilization Form (Exhibit E). Staff recommends the Commission approve TCG's request.

Background

On November 10, 2009, TCG submitted a request to NeuStar for 1 block of one-thousand telephone numbers. On November 10, 2009, the Pooling Administrator denied TCG's request because TCG did not meet the Utilization criteria.

The Telecommunications Department Staff (Staff) reviewed the CO Assignment data that TCG submitted to the Pooling Administrator. TCG's utilization level of 72.85% is below the Federal Communications Commission (FCC) guidelines as set forth in Regulation 47-CFR 52.15 (h)¹ of 75% which is required before a request for additional numbering resources is permissible.

Regulation 47-CFR 52.15 states, the Pooling Administrator shall withhold numbering resources from any U.S. carrier that fails to comply with the reporting and numbering resource application requirements established in this part. The regulation further states that the carrier may challenge the Pooling Administrator's decision to the appropriate state regulatory commission and the state commission may affirm, or may overturn, the Pooling Administrator's decision to withhold numbering resources from the carrier based on the determination that a carrier has demonstrated a verifiable need for numbering resources and has exhausted all other available resources.

Recommendation

TCG's utilization level of 72.85% is below the required utilization level of 75%. Also, TCG does not have 1 block of one-thousand consecutive telephone numbers to accommodate the needs of Midland for 100 consecutive telephone numbers. For this reason, TCG has demonstrated a verifiable need for 1 block of one-thousand additional telephone numbers in the Chesterfield rate center. Staff recommends the Commission issue an order overturning the decision of the Pooling Administrator by granting TCG 1 block of one-thousand telephone numbers in the 636 NPA within any XXXX range other than 0XXX, 18XX, 22XX, 23XX, 32XX, 42XX, 51XX, 62XX, 71XX, 72XX, 75XX, 85XX, and 9XXX in the Chesterfield rate center. Specifically, Staff recommends the Commission's order include a statement substantially as follows:

1. TCG's request for 1 block of one-thousand telephone numbers in the 636 NPA within any XXXX range other than 0XXX, 18XX, 22XX, 23XX, 32XX, 42XX, 51XX, 62XX, 71XX, 72XX, 75XX, 85XX, and 9XXX in the Chesterfield rate center is hereby granted.

Staff is unaware of any other filing that may affect or be affected by this filing.
