**ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF SHEETS**

On April 27, 2010<sup>1</sup>, the Commission received the above-referenced request for name change. It was filed pursuant to Commission Rule 4 CSR 240-2.060(5). Accompanying the request were the above-referenced tariffs, which bear an effective date of May 27, 2010.

On May 13, Staff filed its Recommendation. Staff stated that the applicant has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the tariff sheets.

The Commission has reviewed the application, finds that it substantially complies with Commission Rules 4 CSR 240-2.060(5) and 4 CSR 240-3.545(20), and finds that it should recognize the name change. The Commission will also approve the adoption notice and revised tariff title page.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the name change of NuVox Communications of Missouri, Inc., to Windstream NuVox Missouri, Inc.
