Dear Mr. Goad:

This is in response to your letter regarding the treatment of taxes on C.I.A.C. As you know, the Company's proposed tariff allows the Company to collect the applicable taxes. Your accountant suggested a gross-up of 50%. I have discussed this matter with the staff accountants here at the Public Service Commission. It is the staff recommendation that you gross-up 56% because you can't predict your tax liability for the year due to the uncertainty of the amount of C.I.A.C. the Company may have.

The Company should set up a separate account for these funds. Careful records should be kept of receipt of these funds, payment of taxes from these funds and the refunds to developers or others who paid C.I.A.C. Refunds would be made at the end of the tax year, as soon as the Company ascertains its tax liability for the year. These refunds should be made to the person paying the C.I.A.C. All of these transactions should be shown on a schedule and filed with the Company's annual report to the Commission.

A copy of this letter and the Company's letter will be attached to the Company's tariff.


Enclosed and attached is a letter dated May 8, 1987 from Mr. John Deal,

Dear Mr. Goad:

As you are aware, under current tax codes, contributions in aid of construction are taxable to the Utility.

In the future, it is advisable that the Utility consider the taxes related to the contribution in aid of construction when collecting these funds from contractors. All funds collected from the contractor are taxable, including the amount for taxes.

It would be impossible to ascertain at the beginning of year, the Corporation's tax rate for the year. In fact, to determine the rate at any time during the year would be useless and expensive.


I understand you are negotiating line extensions and facility improvements that will require a CIAC of approximately \$200,000. The tax on a contribution of this amount, including state taxes, would be approximately \$70,000. Taxes on \$270,000, the CIAC plus tax, would be approximately \$100,000.

I suggest you consider adding 50 percent to all CIAC to recover applicable income taxes. Any overage or shortage will be refunded and/or collected from the contractor at the end of the Utility's corporate year when the tax rate is determined.

The above discussion does not include any reference to income or loss from operations, credits, or net operating loss carried forward from prior years. I suggest that the tax rate be determined after determining taxes from operations.

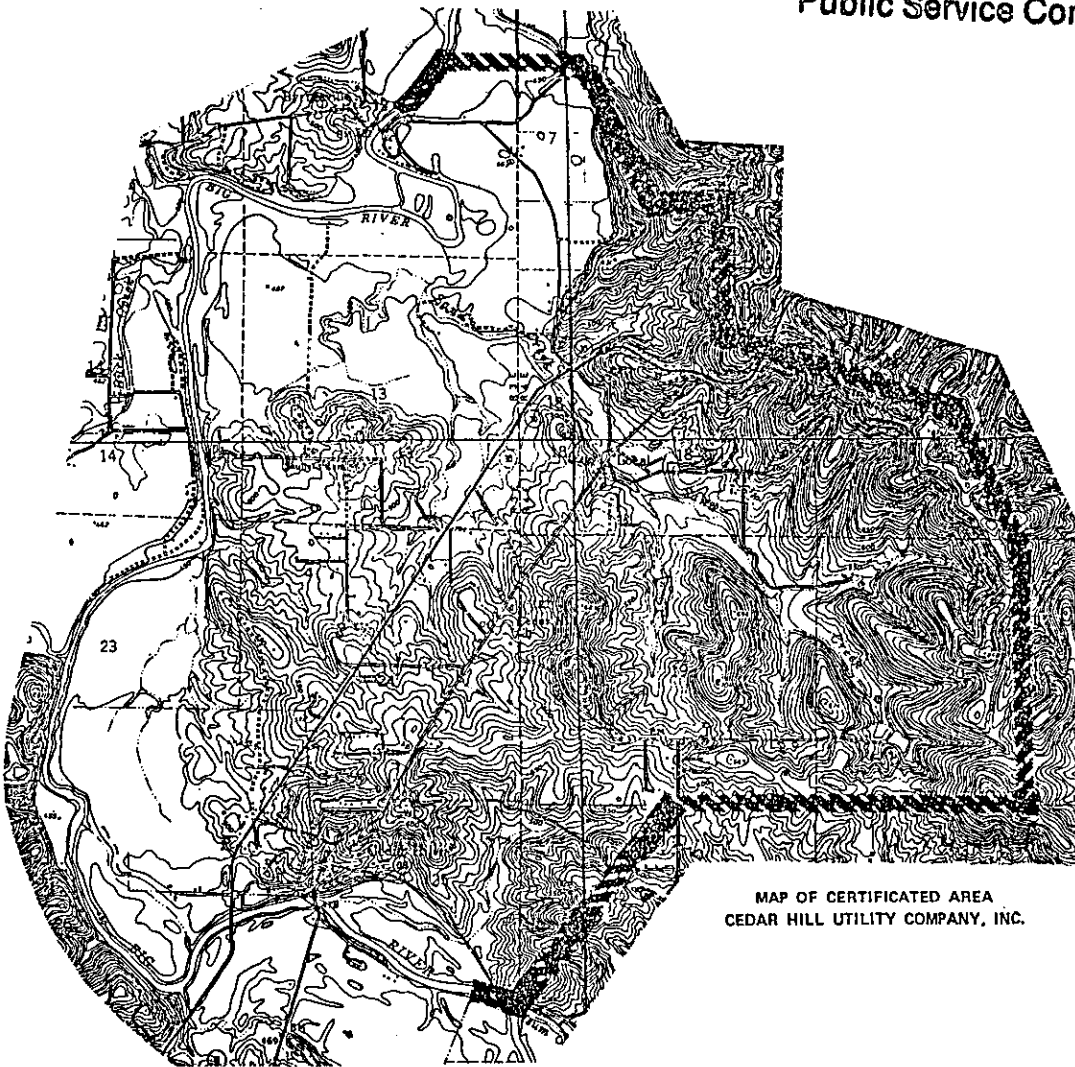

A copy of the Rates and the Rules and Regulations under which sewer service will be supplied is on file with the Missouri Public Service Commission and is available for inspection at the offices of the Company.

Rule 1 GENERAL

- (a) Every customer, upon signing an application for any service rendered by the Company, or upon taking of sewer service, shall be considered to have expressed consent to be bound by these rates, rules and regulations.
- (b) The Company's rules and regulations governing rendering of service are set forth in these numbered sheets. The rates applicable to appropriate service or rate determination areas are set forth in alphabetically numbered sequence with these rules and regulations.
- (c) The Company reserves the right, subject to authority of the Public Service Commission of Missouri, to prescribe additional rates, rules or regulations or to alter existing rates, rules or regulations as it may from time to time deem necessary or proper.
- (d) At the effective date of these rules and regulations, all new facilities, construction contracts, and written agreements shall conform to these rules and regulations in accordance with the Statutes of the State of Missouri and authority of the Public Service Commission of Missouri.
- (e) Properly authorized agents of the company shall have the right to enter upon the premises of the customer at all reasonable times for the purpose of inspecting any appliance of the customer used in connection with this service.

- (4) Commercial - a building premise occupied by and owned or leased by only one (1) business. Service will be charged for each business unit. This service class will include, but not be limited to: office, store, shop, beauty or barber shop, tavern or bar, restaurant, drive-in restaurant, laundromat, service station, motel, nursing home, day school, play ground, and sports facility. Where two or more of the above descriptions might apply, the most restrictive shall be deemed appropriate as the class of service.
- (d) A "COLLECTING SEWER" is a pipeline which is owned and maintained by the Company, located on public property or on private easements, and used to transport sewage wastes to a central point for disposal.
- (e) A "CUSTOMER SERVICE SEWER" is a pipe with appurtenances installed, owned and maintained by the Customer, used to conduct sewage from the Customer's premise to the "collecting sewer".
- (f) A "SERVICE CONNECTION" is the point at which the Customer's service is connected to the collecting sewer through a "Y" branch or saddle, said "Y" branch or saddle to be installed by the customer but owned and maintained by the Company.
- (g) The "DATE OF CONNECTION" shall be the date the permit for a service connection is issued by the Company. In the event no permit is taken and a service connection is made, the date of connection shall be the date of commencement of construction of the building upon the property served.
- (h) "DOMESTIC SEWAGE" is sewage, excluding storm and surface water, resulting from normal household activities.
- (i) "NON-DOMESTIC SEWAGE" is all sewage other than domestic sewage including, but not limited to commercial or industrial waste. (See Rule 6 pertaining to Improper Waste and Excessive Use.)
- (j) A "FOUNDATION DRAIN" is a pipe installed inside or outside the foundation of a structure for the purpose of draining ground

- (k) "pH" is the relative degree of acidity or alkalinity of water as indicated by the hydrogen ion concentration. pH is indicated on a scale reading from 1-14, with 7 being neutral, below 7 acid, and above 7 alkaline; more technically defined as the logarithm of the reciprocal of the hydrogen ion concentration.
- (l) "B.O.D." denotes biochemical oxygen demand. It is the quantity of oxygen utilized in the biochemical oxidation of organic matter under standard laboratory conditions expressed in milligrams per liter.
- (m) "SUSPENDED SOLIDS" are the concentration of insoluble materials suspended or dispersed waste expressed in milligrams per liter on a dry weight basis as determined by standard procedures.
- (n) "INDUSTRIAL WASTE" is any organic or inorganic waste which cannot be treated effectively and safely in the biologic processes normally employed in the treatment of domestic sewage. The receiving and treatment of such wastes will not be considered by the Company.
- (o) MECHANICAL TREATMENT FACILITY - a facility used for the treatment and disposal of sewage waste waters and where this process includes mechanical means for mixing, aerating, and otherwise reducing wastes to meet regulatory requirements for ultimate discharge.
- (p) LAGOON TREATMENT FACILITY - a facility used for the treatment and disposal of sewage waste waters and where this process includes earthen cells wherein the processes of nature, without mechanical support, reduce wastes to meet regulatory requirements for ultimate discharge.

- (a) The Customer will provide the customer service sewer at his expense and risk. The Company shall deny service where footing drains, downspouts, or other sources of uncontaminated water are permitted to enter the system through either the inside piping or through the building sewer.
- (b) Old Customer services sewer may be used in connection with new buildings only when they are found on examination and test to meet all requirements of the Company.
- (c) The Customer's service sewer shall be cast iron soil pipe, ASTM specification or equal; vitrified clay sewer pipe, ASTM specification or equal; or other suitable material approved by the Company. Joints shall be tight and water proof. Any part of the customer's sewer service that is located within ten feet of a water service pipe shall be constructed of cast iron soil pipe with leaded joints. Cast iron pipes with leaded joings may be required where the Customer's service sewer is exposed to damage by tree roots. If installed in filled or unstable ground, the Customer's service sewer shall be of cast iron soil pipe, except that non-metallic material may be accepted if laid on a suitable concrete bed or cradle as approved by the said Company.
- (d) The size and slope of the Customer's service sewer shall be subject to the approval of the Company, but in no event shall the diameter be less than six (6) inches. The slope of such six (6) inch pipe shall not be less than one-eighth (1/8) inch per foot.
- (e) Whenever possible the Customer's service sewer shall be brought to the building at an elevation below the basement floor. No building sewer shall be laid parallel to or within three feet of any bearing wall. The depth shall be sufficient to afford protection from frost. The Customer's service sewer shall be laid at a uniform grade and in straight alignment in so far as possible. Changes in direction shall be made only with properly curved pipes and fittings.

- (a) Prior to discontinuing service the Company will give written notice to the customer by Certified Mail Return Receipt Requested thirty (30) days in advance of such discontinuance and a copy of said notice will be forwarded to the Missouri Public Service Commission. The said notice will state the violation and the date of discontinuance of service should the customer fail to provide satisfactory arrangement for continuance of service.

Rule 10 EXTENSION OF COMPANY FACILITIES

The Company will install additional plant facilities and will extend its collecting sewers along public highways, streets or alleys where grades have been established, or within easements acceptable to the Company to serve new customers within the certificated area of the Company.

This estimate will be provided to the applicant(s) within a reasonable period of time and shall include the direct cost, based upon job records, of all labor and materials of construction, engineering, supervision, permits, insurance, tool expense, accounting and all other costs related to acquisition of required easements. This estimate shall be dated and considered as effective and binding upon the Company for a period of 120 days from said date.
- (b) Applicants shall enter into a contract with the Company for the engineering design and the installation of said extension and shall tender to the Company a Contribution-in-Aid-of-Construction (CIAC) equal to the amount determined under paragraph (a) above, plus applicable connection charges as set forth in Rule 4 for all customer service sewers proposed by the applicant(s) to be connected to the extension. Such deposits shall be refunded at the termination of service after all charges that may be due and payable by the Customer have been paid.
- (d) Each Customer is responsible for furnishing the Company with his correct address. Failure to receive bills will not be considered an excuse for non-payment nor reason to permit an extension of the date when the account would be considered delinquent.

Rule 12 SERVICE CHARGES

MISSOURI
Public Service Commission

- (a) An Application for a service connection, or discontinuation of existing service, will be made during the Company's regular business hours without charge.
- (b) A connection of service to a specific customer which was discontinued in Accordance with Rules 7 and 11 will be made according to Rule 7 of these Rules and Regulation.
- (c) A service man call during the Company's regular business hours which results in collection of a delinquent account (in lieu of discontinuance in accordance with Rule 7) shall require collection of the delinquent amount plus a fifteen dollar (\$15.00), net service charge to avoid discontinuance.
- (d) A service call at any time other than during the Company's regular business hours 8:00 a.m. to 4:30 p.m. for connection, or any other reason except blockage of the Company's sewer main, shall require a service charge of thirty dollars (\$30.00) net. In instances where such a service call is for collection of a delinquent account, this service charge shall be collected in addition to any other amount due.
- (e) Company personnel will not work upon sewer piping or facilities not owned by the Company.
- (f) Delinquent payment charges:
- (1) When a current billing has not been paid in full by the due date, there will be assessed a LATE CHARGE of two dollars (\$2.00).
- (2) When a bill has not been paid in full, inclusive of late charge, by the due date of the next succeeding billing cycle, there will be assessed an additional DELINQUENT CHARGE of ten dollars (\$10.00). Thereupon, if the account is not paid in full, inclusive of LATE and DELINQUENT charges by due date of this subsequent billing, service will be discontinued as provided in Rule 7.
