**ORDER CANCELLING TARIFFS**

Issue Date: August 17, 2017

Effective Date: August 27, 2017

On August 2, 2017, Laclede Gas Company filed a motion to withdraw and cancel the inoperable tariffs of Fidelity Natural Gas Company. The Commission approved Laclede's ownership of Fidelity effective February 24, 2006, and Laclede adopted Fidelity's tariffs. Additionally, Fidelity's certificate of convenience and necessity was canceled effective May 1, 2006. Further, as part of the Stipulation and Agreement approved by the Commission in File No. GR-2007-0208, Laclede was required to make a filing withdrawing and canceling Fidelity's tariffs.

Laclede states that the Staff of the Missouri Public Service Commission (Staff) and the Office of the Public Council have no objection. The Commission sent notice to the parties in File No. GR-2007-0208 and no party objected or requested to intervene in this matter. Therefore, these tariffs are no longer operable and shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The tariffs of Fidelity Natural Gas, Inc. shall be canceled.

2. This order shall be effective on August 27, 2017.


