## Dear Secretary Woodruff,

Accompanying this letter for filing via the Commission's Electronic Filing and Information System ("EFIS") are revised tariff sheets designed to increase Spire Missouri's aggregate annual gross base rate revenues by \$78 million, as supported by the Commission's November 30, 2022 Order Approving Stipulation and Agreement ("the Order"). This equates to approximately a 3.4% bill increase or \$3.06 a month for the average Spire Missouri East customer and approximately a 4.9% bill increase or \$4.76 a month for the average Spire Missouri West customer. The bill impact could be higher or lower depending on customer usage.

Please note that the Company filed these tariffs as soon as practical after issuance of the Order. The company has been working with Staff for several weeks on tariff correspondence. Spire is requesting expedited treatment to permit the Revised Tariff Sheets to become effective on December 26, 2022.

The accompanying tariff sheets issued by Spire Missouri are transmitted to you for filing as <u>P.S.C. MO. No. 9</u>, Schedule of Rates and Charges Applying to Spire Missouri Service Areas and Spire Missouri Rules and Regulations. Also included is a First Revised Sheet 11.5 to the Purchased Gas Cost Adjustment sales and purchases volumes due to an error in calculation when converting from Therms to Ccf which happened in case GR-2021-0108. Information on the Therm to Ccf calculation has been provided to Staff.

Please bring this filing to the attention of the appropriate Commission personnel.
