## ORDER APPROVING TARIFFS

Issue Date: May 15, 2023

Effective Date: May 28, 2023

On May 3, 2023, the Commission issued its Report and Order (Order). That Order authorized Missouri-American Water Company (MAWC) to file tariffs that comply with the Order.

On May 3, 2023, MAWC filed Tariff Tracking Nos. YW-2023-0196 and YS-2023-0197. Those tariffs bear effective dates of June 2, 2023. On May 10, 2023, MAWC filed Tariff Tracking Nos. YW-2023-0201 and YS-2023-0202. Those tariffs bear effective dates of June 10, 2023.

MAWC filed motions for expedited treatment for all of these tariffs, asking the Commission to approve the tariffs no later than May 28, 2023. MAWC states that good cause exists to approve these tariffs on less than thirty days' notice. The good cause includes the tariff filing being done to comply with the Order, the Commission and the

public being aware of MAWC's proposed rate increase for over ten months, and the operation of law date for this case being May 28, 2023.

On May 11, 2023, Staff filed its Recommendation. Staff stated that it reviewed the tariff sheets, and that Staff recommends the Commission approve them. Staff does not object to MAWC's motions for expedited treatment. The Commission received no other responses to the tariff filing or Staff's Recommendation.

The Commission reviewed the tariff filings and Staff's Recommendation, and determines that the filings comply with the Commission's Order. The Commission further finds that MAWC has stated good cause for the Commission to approve the tariffs on less than thirty days' notice.

**THE COMMISSION ORDERS THAT:**

1. The Motions for Expedited Treatment are granted.
2. The tariff sheets in Tracking No. YW-2023-0196 and YS-2023-0197, issued May 3, 2023, and the tariff sheets in Tracking No. YW-2023-0201 and YS-2023-0202, issued on May 10, 2023, are hereby approved to become effective on May 28, 2023.
3. This order shall be effective on May 28, 2023.
