ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: February 8, 2007 Effective Date: February 18, 2007

On January 24, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and the accompanying tariff of Infone LLC, a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number XA-2002-1081, the Commission granted North By NortheastCom LLC a certificate of service authority to provide intrastate interexchange telecommunications services. In XN-2003-0519, the Commission approved North By NortheastCom LLC's change of name to Infone LLC and approved the company's current tariff, P.S.C. Mo. No. 3.

Staff's motion states that through a letter from Infone's agent and consultant, Infone requested the Commission cancel its certificate of service authority because it ceased all regulated operations in Missouri. Infone owes no annual reports or assessments and no complaints have been filed against the company since the commencement of the Commission's Electronic Filing and

Information System. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, P.S.C. Mo. No. 3, to provide intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and Infone's request to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Infone LLC, shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Infone LLC, formerly known as North By NortheastCom LLC, in Case Number XA-2002-1081, is canceled.
- 2. Infone LLC's tariff, P.S.C. Mo. No. 3, granted in Case No. XN-2003-0519, is canceled.
 - 3. This order shall become effective on February 18, 2007.

4. This case may be closed on February 19, 2007
