Attached for electronic filing are revisions to the P.S.C. MO. No. 1 General and Local Exchange Tariff for CenturyTel of Missouri, LLC d/b/a CenturyLink. These revisions are filed in accordance with Missouri Public Service Commission Rules and Regulations and electronically submitted with a July 31, 2014 issue date and a proposed effective date of September 1, 2014.

This filing proposes rate changes for residence One-Party Local Exchange Service. Proposed rate increases for residential basic service are compliant with House Bill No. 1779 which limits the amount by which basic service may be increased in exchanges not explicitly deemed competitive by the PSC. Additionally, rates are being increased for various packaged services, including a promotional offer.

In accordance with provisions of 4 CSR 240-3.545, enclosed as Attachment A is a summary of the changes being proposed in this filing. Attachment B contains the advance customer bill notification. Customers are being notified a minimum of thirty days prior to the implementation of the proposed rate increases.

  - c. During the period November 12, 2009 through September 30, 2010, the Company will waive the nonrecurring charges for installation of additional business access lines, including additional Centrex or Key Lines. This offer does not include PBX trunks.
  - d. Second Line \$9.95 Bundle promotion

During the period November 12, 2009 through December 31, 2011, a bundled service offering is available to residential customers with at least one residential one-party access line. The offering includes an additional residential one-party access line with Call Waiting. The Company will waive the appropriate nonrecurring charges for residential customers subscribing to this promotion.
