## ORDER CANCELING CERTIFICATE AND **ACCOMPANYING TARIFFS**

Issue Date: January 29, 2015

Effective Date: February 8, 2015

On January 15, 2015, the Staff of the Missouri Public Service Commission filed a motion requesting TSI's ("TSI") certificates of service authority and accompanying tariffs to provide competitive basic local and interexchange telecommunication services in the State of Missouri be cancelled.

In File Numbers CA-2004-0204 and XA-2004-0214, the Commission granted TSI certificates of service authority to provide competitive basic local and interexchange telecommunication service in the State of Missouri. The Company's tariffs, P.S.C. Mo No. 1 and 3, were also approved.

Staff states in its motion that TSI notified the Commission that TSI no longer wished to retain its certificate of service authority. Staff recommends that the Commission cancel the company's certificates of service authority to provide competitive basic local and interexchange telecommunications services, and the company's accompanying tariffs.

On January 16, 2015, the Commission issued an Order Establishing Time to Respond allowing any parties to file an objection or request a hearing to do so no later than January 26, 2015. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificates of service authority and accompanying tariffs granted to TSI, shall be canceled.

## IT IS ORDERED THAT:

- 1. The certificate of authority to provide competitive basic local and interexchange telecommunications services granted to TSI, in File Numbers CA-2004-0204 and XA-2004-0214, is canceled.
  - 2. TSI's tariff, P.S.C. Mo No. 1, is canceled.
  - 3. TSI's tariff, P.S.C. Mo No. 3, is canceled.
  - 4. This order shall become effective on February 8, 2015.
  - 5. This case may be closed on February 9, 2015.
