

In the Matter of Total Call International,)
LLC to Cancel its Authority to Provide) **File No. XD-2017-0091**
Interexchange Services and Existing Tariffs) Tracking No. YX-2015-0311

On October 5, 2016, the Commission issued an Order Directing Staff to File a Recommendation. On September 30, 2016, Staff filed its recommendation and stated that Total Call no longer wished to retain its certification to provide telecommunications services in Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide telecommunications services and the company's accompanying tariff.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Total Call’s request and Staff’s recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to Total Call International, LLC, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Total Call International, LLC, in File Number TA-2001-510, is canceled.
2. Total Call International, LLC’s tariff, P.S.C. MO No. 1 is canceled.
3. This order shall become effective on November 5, 2016.
4. This case may be closed on November 6, 2016.
