**ORDER APPROVING TARIFF SHEETS IN COMPLIANCE
WITH COMMISSION ORDER**

Issue Date: January 18, 2022

Effective Date: January 30, 2022

On December 15, 2021, the Commission issued its order granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) sewer certificates of convenience and necessity. On December 31, 2021, Confluence Rivers filed compliance tariff sheets, Tariff No. YS-2022-0197, to incorporate the previously unregulated Shelton Estates Sewer Company and Prairie Heights, LLC sewer systems into Confluence Rivers' existing tariff. The proposed compliance tariff sheets have an effective date of January 30, 2022.

The Commission ordered its Staff to file a recommendation regarding the compliance tariffs. On January 13, 2022, Staff recommended the Commission approve the compliance tariff sheets. After reviewing the compliance tariff sheets and Staff's recommendation, the Commission finds that Confluence Rivers' tariff sheets comply with the Commission's order granting Certificates of Convenience and Necessity, and will approve them. So that Confluence Rivers can implement the compliance tariff sheets on their effective date, the Commission finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Confluence Rivers' compliance tariff sheets, Tariff No. YS-2022-0197, are approved to become effective on January 30, 2022. The approved tariff sheets are:
