Enclosed for filing with the Missouri Public Service (“Commission”) on behalf of Laclede Gas Company doing business as Missouri Gas Energy (“MGE” or “Company”), please find in electronic format certain revised tariff sheets.

These tariff sheets are being filed to comply with the Commission’s Report and Order issued in Case No. GR-2014-0007 on April 23, 2014, effective May 1, 2014. These compliance tariff sheets are designed to produce an increase in annual revenues of \$7,800,000, excluding gross receipts taxes, franchise fees or other similar fees or taxes.
