On April 17, 2020, The Empire District Electric Company ("Liberty") filed an application for approval of a Community Solar Pilot Program ("CSPP"), along with proposed tariff sheets. The CSPP was approved by the Commission, and CSPP tariff sheets took effect. Liberty's first facility under the CSPP, the Prosperity Community Solar Farm, is fully subscribed and operational.

Liberty seeks to officially begin accepting subscriptions for a second CSPP facility. In this regard, revised tariff sheets were submitted herein. On April 18, 2023, Liberty and Staff filed a Stipulation and Agreement with agreed upon tariff language to begin implementing the process for Liberty's second CSPP. The Stipulation and Agreement was approved by the Commission by order issued May 3, 2023. In compliance with this order, the following revised tariff sheets are being submitted:
