This tariff sheets are being issued November 22, 2019 to become effective on and after January 21, 2020.

The proposed tariff revisions are being filed by Ameren Missouri to adjust customer rates to reflect the costs and other recoverable items associated with the Company's approved energy efficiency programs. The new rates, to be applicable on and after February 1, 2020, are located on Original Sheet No. 91.23 and certain other Rider EEIC language has been modified to support Rider EEIC rates being applicable on a calendar basis. If the proposed revisions are approved, Rider EEIC rate will be applicable in the same manner as Company's Rider RESRAM (previously approved) and Rider FAC (proposed in ER-2019-0335).

The proposed language changes and rate table relocation were provided to Staff prior to filing.
