Pursuant to Section 51.911(c) of the Federal Communications Commission's rules, 47 C.F.R. §51.911(c), the Federal Communications Commission's October 9, 2020 *Report and Order* in WC Docket No. 18-156, FCC 20-143, ("8YY R&O") and Section 51.911(c) of the Federal Communications Commission's rules, 47 C.F.R. §51.911(c), Preferred Long Distance, Inc. dba Telplex Communications dba Telplex ("Telplex") submits to the Missouri Public Service Commission revised sheet 40 to its Missouri switched exchange access service tariff, Missouri P.S.C. Tariff No. 2.
