ORDER APPROVING TARIFFS

Issue Date: October 24, 2018

Effective Date: November 3, 2018

On August 27, 2018, KCP&L Greater Missouri Operations Company (GMO) submitted tariff sheets, Tariff Tracking No. JE-2019-0026, to establish its Limited Large Customer Economic Development Rider in compliance with Section 393.1640, RSMo. At Staff's request, the Commission suspended those tariff sheets by order issued on September 25, 2018, pending resolution of a potential substantive dispute. Subsequently, GMO filed several substitute tariff sheets, with the most recent substitute sheets being filed on October 18, 2018, and asked that the tariff sheets be approved to become effective on November 3, 2018.

Because GMO had previously asked that these tariffs be approved on an expedited basis due to inquiries from customers wanting to implement the terms of the rider, the Commission directed that GMO file a clarification explaining its requested effective date and shortened the time for responses to the tariff sheets. On October 22, 2018, GMO filed its clarification requesting that the tariff sheets, as substituted on October 18, become effective no later than November 3, 2018. This will allow GMO to better meet the needs of potential customers. Staff filed a response on October 23, 2018, stating it had no objection.

No party objects to these tariff sheets becoming effective on November 3, 2018. Additionally, an opportunity to request a hearing has been provided and no party has requested one. An evidentiary hearing is not necessary to grant unopposed relief.¹

After reviewing the tariff sheets, as substituted on October 18, 2018, and the responses, the Commission finds that Tariff No. JE-2019-0026 should be approved, as substituted. Further, because the company originally filed proposed tariff sheets on August 27, 2018, no party objects, and the company has had customer inquiries about the availability of this program, the Commission finds there is good cause to make this order and the tariff sheets effective on November 3, 2018.

THE COMMISSION ORDERS THAT:

1. The previously suspended tariff sheets filed on August 25, 2018, as substituted on October 18, 2018, in Tariff No. JE-2019-0026, are approved effective November 3, 2018.
2. This order shall be effective on November 3, 2018.
3. This case shall close on November 4, 2018.
