**ORDER APPROVING FUEL ADJUSTMENT TRUE-UP AND APPROVING  
TARIFF TO CHANGE FUEL ADJUSTMENT CLAUSE RATES**

Issue Date: May 17, 2017

Effective Date: June 1, 2017

In each of these files, The Empire District Electric Company (“the company”) filed a tariff<sup>1</sup> (“tariff”) and supporting testimony,<sup>2</sup> Staff filed a favorable recommendation,<sup>3</sup> and the Office of the Public Counsel filed a response offering no opposition.<sup>4</sup>

In File No. EO-2017-0255, the company seeks the Commission’s approval of true-up amounts related to the company’s fuel adjustment clause (“FAC”).<sup>5</sup> Specifically, the amounts relate to the company’s Recovery Period 15 (June 2016 through November 2016).

For that period, the company alleges a true-up amount of \$5,816 in under-recovery and interest. Those amounts are components of the FAC for the company's Accumulation Period 17, which is the subject of File No. ER-2017-0254. In that case, the company asks to adjust the company's rates per kilowatt hour ("kWh") by \$0.00614 for primary service and \$0.00625 for secondary service. For a residential customer using 1,000 kWh per month, the tariff increases the FAC by approximately \$6.25 per month from -\$4.57 to \$1.68.

On the basis of the verified and uncontested filings, the Commission concludes that the tariff conforms to the applicable statutes, regulations, and tariffs, so the Commission will approve the tariff.

**THE COMMISSION ORDERS THAT:**

1. The tariff assigned Tracking No. JE-2017-0191 is approved to become effective on June 1, 2017, subject to true-up and prudence review.
