ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, DIRECTING FILING, AND SUSPENDING TARIFF

On August 20, 2018, Missouri-American Water Company ("MAWC") filed an application and petition with the Missouri Public Service Commission pursuant to Sections 393.1000, 393.1003, and 393.1006, RSMo 2016, and Commission Rules 4 CSR 240-2.060 and 3.650, requesting that the Commission authorize it to change its Infrastructure System Replacement Surcharge ("ISRS"). Section 393.1006.2(3), RSMo, requires that the Commission act on the application no later than 120 days after the petition was filed; therefore, the Commission must issue an order regarding the application effective no later than December 18, 2018.¹

Section 393.1006.1(2), RSMo, requires that the Commission publish notice of the filing. Therefore, the Commission will give notice of this application to the general public and interested persons and set a date for intervention. The Commission's Data Center shall mail a copy of this notice to the county commission, or equivalent governmental body, of all counties within MAWC's service area. The Data Center shall also mail a copy of this notice to the parties in MAWC's last rate case, File No. WR-2017-0285. In addition, the Commission's Public Policy and Outreach Department shall make notice of this order

available to the media serving MAWC's service area, and to the members of the General Assembly representing MAWC'S service area.

Section 393.1006.2(2), RSMo, allows the Commission's Staff to examine MAWC's application to change its ISRS and allows Staff to submit a report of its examination no later than sixty days after the petition is filed. Consequently, the Commission will establish a deadline for Staff to file a recommendation regarding the application.

In addition, MAWC filed a related tariff sheet, bearing an effective date of September 19, 2018. Because the Staff Recommendation will not arrive before the effective date for the tariff, the Commission shall suspend the tariff.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve notice as set out in the body of this order.

2. The Commission's Public Policy and Outreach Department shall serve notice as set out in the body of this order.

3. Any entity wishing to intervene in this matter shall file an application to do so no later than September 6, 2018.

4. No later than October 19, 2018, the Staff of the Missouri Public Service Commission shall file its recommendation in this matter.

5. The following revised tariff sheet filed by Missouri-American Water Company on August 20, 2018, and assigned Tariff File No. YW-2019-0018, is suspended until December 18, 2018, or until otherwise ordered by the Commission:
