On March 30, 2022, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) submitted 6th Revised Sheet No. 71.15, which is part of Schedule No. 6, Schedule of Rates for Electric Service, and which was to supersede 5th Revised Sheet No. 71.15 (the "Original Tariff Sheet"). The Original Tariff Sheet was filed to effectuate the change in the FAR rates provided for in the Company's Rider FAC and bore an effective date of June 1, 2022.

The Commission's Staff has been engaged in review of the Original Tariff Sheet and the related Fuel Adjustment Rate ("FAR") filing made in this docket, and as part of its review contacted the Company about a typographical error on line 13. More specifically, there is a zero missing behind the decimal place on that line (the Original Tariff Sheet has a value of \$0.0041/kWh and it should be \$0.00041 per kWh). Consequently, submitted herewith is a substitute tariff sheet showing the correct figure on line 13 of \$0.00041. This substitute tariff sheet will implement the Company's Fuel and Purchased Power Adjustment for the 39th Accumulation Period January 31, 2022, and also includes the amounts to be trued-up for the 36th Recovery Period under the Company's Rider FAC. This substitute tariff sheet bears the same effective as the Original Tariff Sheet, June 1, 2022.
