Enclosed please find the following tariff sheet that has been issued by The Empire District Gas Company (EDG):

- P.S.C. Mo. No. 2, 1st Revised Sheet No. R-51i, canceling P.S.C. Mo. No. 2, Original Sheet No. R-51i

The purpose of the proposed tariff sheet is to extend the Home Performance with Energy Star Program originally put in place as a result of the Commission's approval of the Partial Stipulation and Agreement in Commission Case No. GR-2009-0434, for a three year period. In the absence of such extension, this program, among others, will have terminated as of April 1, 2013, and not be available to EDG's customers.

EDG previously filed, on April 12, 2013, a series of tariff sheets related to other demand side management programs for this same purpose. Those sheets are identified by Tracking Number JG-2013-0445. The attached tariff sheet was inadvertently left out of that previous filing.

The above tariff sheet carries an issue date of April 24, 2013, and a proposed effective date of May 24, 2013 (thirty days). Because the JG-2013-0445 tariffs are proposed to be effective on May 12, 2013, we are also filing this date a Motion for Expedited Treatment asking that this tariff sheet also become effective on May 12, 2013.


