On December 31, 2020, Liberty submitted a Verified Infrastructure System Replacement Surcharge (“ISRS”) Application in Case No. GT-2021-0073. A proposed tariff sheet was attached to the Application as Attachment 1 of Appendix C, but the tariff sheet was not filed separately in EFIS at that time.

On January 14, 2021, Liberty provided to the Missouri Public Service Commission for filing, in electronic form, the following revised ISRS tariff sheet:

Form No. 13 PSC MO No. 2 11th Revised Sheet No. 19

The revised ISRS tariff sheet submitted on January 14, 2021, proposed an effective date 60 days thereafter (March 15, 2021). Liberty later voluntarily extended the proposed effective date to June 1, 2021, and the ISRS tariff sheet was then substituted on March 2, 2021.

A further substitution for the 11th Revised Sheet No. 19 is being submitted for filing at this time, in compliance with Staff’s recommendation in this matter, with a proposed effective date of June 1, 2021. A redlined tariff sheet is also being provided to Staff and the Office of the Public Counsel.
