ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: November 17, 2009 Effective Date: November 27, 2009

On October 30, 2009, the Staff of the Missouri Public Service Commission filed a motion requesting GTC Telecom, d/b/a GTC Telecom, Inc.'s ("GTC Telecom") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunications services in the State of Missouri be canceled.

In File Number TA-99-347, the Commission granted GTC Telecom a certificate of service authority to provide intrastate interexchange telecommunications service in the State of Missouri. The Company's tariff, P.S.C. Mo. Tariff No. 1, was also approved.

Staff states in its motion that according to the Missouri Secretary of State, GTC Telecom was administratively dissolved on February 11, 2009, for failing to file a current and correct annual report. GTC Telecom has not filed an annual report with the Commission for 2008. GTC Telecom owes the Commission \$27.74 in assessments for Fiscal Year 2009. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On November 2, 2009, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than November 12, 2009. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to GTC Telecom, d/b/a GTC Telecom, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide intrastate interexchange telecommunications services granted to GTC Telecom, d/b/a GTC Telecom, Inc., in File Number TA-99-347, is canceled.
- 2. GTC Telecom, d/b/a GTC Telecom, Inc.'s tariff, P.S.C. Mo. Tariff No. 1, is canceled.
 - 3. This order shall become effective on November 27, 2009.
 - 4. This case may be closed on November 28, 2009.
