## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 29, 2012

Effective Date: September 8, 2012

On August 13, 2012, the Staff of the Missouri Public Service Commission filed a motion requesting QX Telecom, LLC ("QX Telecom") certificate of service authority and accompanying tariff to provide intrastate interexchange and nonswitched local exchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-2002-234, the Commission granted QX Telecom a certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that the Missouri Secretary of State's Office revoked the Company's authority to do business in the state of Missouri for failure to maintain a registered agent. Staff noted that QX Telecom is deficient in the filing of the Company's annual report for calendar year 2011 and has failed to correct deficiencies in its 2010 annual report. QX Telecom is also delinquent on its payment of its fiscal year 2012 and 2013 assessments. Staff has been unsuccessful in

contacting the company. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications services, and the company's accompanying tariff.

On August 14, 2012, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than August 24, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to QX Telecom, LLC, shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide intrastate interexchange and nonswitched local exchange telecommunications services granted to QX Telecom, LLC, in File Number TA-2002-234, is canceled.
2. QX Telecom, LLC's tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on September 8, 2012.

4. This case may be closed on September 9, 2012.
