ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: August 2, 2022

Effective Date: August 4, 2022

On June 29, 2022, the Commission issued an *Amended Report and Order* (Order) in this matter. Among other things, that order directed Missouri-American Water Company (MAWC) to submit tariff sheets applicable to the water service and sewer service in the requested service area in P.S.C. MO No. 13 (water) and 26 (sewer), to become effective before closing on the assets.

On July 5, 2022, MAWC filed new tariff sheets purporting to be in compliance with the terms of the Commission's Order. The new tariff sheets carry a 30-day effective date of August 4, 2022.

On July 22, 2022, the Staff of the Commission (Staff) filed its recommendation that the tariff sheets be approved. Per Commission Rule 20 CSR 4240-2.080(13), ten days were allowed for the filing of any responses to Staff's recommendation or the proposed tariff sheets. No responses or objections were received, thus the Commission will take up MAWC's compliance tariff sheets unopposed.

Upon reviewing the pleadings and Staff's recommendation, the Commission finds MAWC's proposed tariff sheets comply with the Commission's Order and will approve

them. To accommodate MAWC's chosen tariff effective date, the Commission will make this order effective in less than 30 days, and will approve the proposed tariff sheets to become effective on August 4, 2022.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets filed on July 5, 2022, by MAWC, and assigned Tracking No. YW-2023-0006 and Tracking No. YS-2023-0007, are approved to become effective on August 4, 2022.
2. This order shall be effective on August 4, 2022.
