("SNGMO" or the "Company") for its three PGA divisions of Gallatin, Warsaw and Lake of the Ozarks, and the Rogersville and Branson service areas:

The accompanying substitute revised tariff sheets have an issue date of November 2, 2022, and an effective date of November 17, 2022.

This substitute tariff filing corrects an error identified by Staff that impacts the calculation of the PGA rate for the two PGA rate divisions of Warsaw and Lake of the Ozarks and Rogersville and Branson. The workpapers supporting the calculation of the PGA rates have since been corrected and were filed on November 4, 2022 in Docket No.GR-2022-0191. There is no impact to the PGA rate previously filed for the Company's Gallatin division, however, the Company has submitted that tariff again here so that the Commission may have a complete view of SNGMO's PGA tariffs.

These revised tariff sheets reflect the Purchased Gas Adjustment ("PGA") of the Company as set forth in the Company's tariffs, as well as the carrying cost rates for Winter Storm Uri as stipulated by the Parties and approved by the Commission in Case No. GR-2022-0122. These revisions include adjustments to the Regular Purchased Gas Adjustment ("RPGA") and Actual Cost Adjustment "(ACA") factors.

The changes in the PGA factors applicable to the Company's Gallatin Division will increase the firm sales customers' total PGA rate from \$0.6538/Ccf to \$1.1583/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$65.27. This represents a 36.26% increase for the average month in the heating season.

The changes in the PGA factors applicable to the Company's Warsaw and Lake of the Ozarks Divisions will increase the firm sales customers' total PGA rate from \$0.9869/Ccf to \$1.4409/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$25.51. This represents a 19.77% increase for the average month in the heating season.



The changes in the PGA factors applicable to the Company's Rogersville and Branson Divisions will increase the firm sales customers' total PGA rate from \$0.9942/Ccf to \$1.4048/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$39.35. This represents a 20.85% increase for the average month in the heating season.

These revised tariff sheets reflect the Purchased Gas Adjustment ("PGA") of the Company as set forth in the Company's tariffs, as well as the carrying cost rates for Winter Storm Uri as stipulated by the Parties and approved by the Commission in Case No. GR-2022-0122. These revisions include adjustments to the Regular Purchased Gas Adjustment ("RPGA") and Actual Cost Adjustment "(ACA") factors. The changes in the PGA factors applicable to the Company's Gallatin Division will increase the firm sales customers' t otal PGA r a t e from \$0.6538/Ccf to \$1.1583/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$65.27. This represents a 36.26% increase for the average month in the heating season.

The changes in the PGA factors applicable to the Company's Warsaw and Lake of the Ozarks Divisions will increase the firm sales customers' total PGA rate from \$0.9869/Ccf to \$1.4094/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$23.74. This represents a 18.40% increase for the average month in the heating season.



The changes in the PGA factors applicable to the Company's Rogersville and Branson Divisions will increase the firm sales customers' total PGA rate from \$0.9942/Ccf to \$1.4326/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$42.01. This represents a 22.26% increase for the average month in the heating season.

We are enclosing workpapers supporting this filing with the copy of this filing being provided to the Staff. The workpapers have been designated "Confidential" since they contain market specific information directly relating to the natural gas markets where Summit Natural Gas of Missouri, Inc. must compete for its gas supplies. The Company requests that these workpapers be handled in a manner consistent with this designation.

The proposed increase will cause an average winter month residential gas bill to increase by approximately \$65.27. This represents a 36.26% increase for the average month in the heating season.

The changes in the PGA factors applicable to the Company's Warsaw and Lake of the Ozarks Divisions will increase the sales customers' t otal PGA r at e from \$0.9869/Ccf to \$1.4094/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$23.74. This represents a 18.40% increase for the average month in the heating season.

The changes in the PGA factors applicable to the Company's Rogersville and Branson Divisions will increase the firm sales customers' total PGA rate from \$0.9942/Ccf to \$1.4326/Ccf. The proposed increase



will cause an average winter month residential gas bill to increase by approximately \$42.01. This represents a 22.26% increase for the average month in the heating season.

We are enclosing workpapers supporting this filing with the copy of this filing being provided to the Staff. The workpapers have been designated "Confidential" since they contain market specific information directly relating to the natural gas markets where Summit Natural Gas of Missouri, Inc. must compete for its gas supplies. The Company requests that these workpapers be handled in a manner consistent with this designation.
