## **ORDER APPROVING EXPEDITED COMPLIANCE TARIFFS**

Issue Date: October 17, 2013 Effective Date: October 20, 2013

On October 3, 2013, the Commission approved a stipulation and agreement resolving all pending issues surrounding customer opt-out of Kansas City Power & Light Company's (KCPL&L's) demand-side programs. Among other things, that stipulation and agreement required KCP&L to issue tariffs to implement the terms of the agreement. KCP&L issued the tariff necessary to comply with the agreement on October 10.

Those tariffs carry a thirty-day effective date that would make them effective on November 9. However, along with its tariffs, the company filed a motion asking the Commission to approve the tariffs to take effect on October 20. The company explains that expedited approval of the tariffs is appropriate because all parties to the stipulation and agreement have already reviewed the tariffs, which simply comply with the requirements of that stipulation and agreement.

In response to the motion for expedited treatment, the Commission directed its Staff to file a recommendation regarding the tariffs no later than October 16. The Commission also ordered that any other party wanting to file a recommendation regarding the tariffs do so no later than October 16. On October 16, the Commission's Staff filed its recommendation advising the Commission to approve the tariffs to be effective on October 20 as requested. Staff explains that expediting approving the compliance tariffs will allow the opt-out provisions to be available for use by KCP&L customers within the 2013 opt-out period that ends on October 30, 2013. No other party filed a recommendation regarding the tariffs

Based on the recommendation of its Staff, the Commission finds that the submitted tariffs should be approved on less than thirty days' notice.

#### THE COMMISSION ORDERS THAT:

1. The tariff sheets submitted under Tariff Nos. YE-2014-0169 and YE-2014-

0170 by Kansas City Power & Light Company are approved, effective on and after October
