Dear Judge Woodruff:

On December 30, 2021, Liberty submitted a Verified Infrastructure System Replacement Surcharge ("ISRS") Application and a revised ISRS tariff. On January 3, 2022, the Commission issued its *Order and Notice* regarding these filings and directed the Staff of the Commission ("Staff") to file a report no later than March 30, 2022. At the suggestion of Staff, Liberty is submitting this tariff filing cover letter at this time.

Liberty's current ISRS was established in Commission Case No. GT-2021-0073, effective June 1, 2021. That filing covered ISRS costs incurred during the period April 1, 2018, through October 31, 2020. The Company continued to make ISRS eligible investments, and the Application and revised tariff filed on December 30, 2021, reflect these additional investments covering the period November 1, 2020, through October 31, 2021.

Liberty's proposed revised ISRS tariff bears an issue date of December 30, 2021, and a proposed effective date of April 1, 2022, but the Commission has suspended that tariff until June 28, 2022.

SCHEDULE OF RATES

INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE (“ISRS”)

Description: The ISRS is designed to recover the costs associated with the Company’s eligible infrastructure replacements in accordance with the provisions of Sections 393.1009 to 393.1015, RSMo.

Applicability: In addition to the other charges provided for in the Company’s tariff, a monthly ISRS shall be added to each customer’s bill for service rendered on and after the effective date of the ISRS.

Schedule of Surcharges: The amount of the ISRS by rate schedule is as follows:
