ORDER APPROVING TARIFF

Issue Date: October 14, 2021

Effective Date: October 24, 2021

On September 24, 2021, Spire Missouri, Inc. filed an application for approval of a tariff that will amend the Purchased Gas Adjustment Rider for Spire Missouri West. The amended tariff will allow Spire to mitigate some of the rate impacts of the February 2021 cold weather event by spreading the recovery of costs over a period of up to three years. Spire Missouri's tariff carries a 30-day effective date of October 24, 2021.¹

The Commission ordered its Staff to file a recommendation by October 8, 2021, and allowed any other interested party to respond by that same time. Staff filed its recommendation on October 8. No other party responded.

Staff recommends the Commission approve the submitted tariff to be effective on October 24, as requested. The Commission will do so. Because the tariff will be approved to be effective in less than thirty days from the date of this order, this order will be made effective in less than thirty days.

¹ Spire Missouri also asked the Commission to waive the 60-day notice requirements of Commission Rule 20 CSR 4240-4.017(1). Spire Missouri has shown good cause for the waiver of that requirement and it will be waived.

THE COMMISSION ORDERS THAT:

1. The tariff amendment submitted by Spire Missouri on September 24, 2021 (Tariff No. JG-2022-0061) is approved to be effective on October 24, 2021. The tariff sheet approved is:

2. The 60-day notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
