**Re: Notice of Election to Be Exempt from Certain Tariff Filing
Requirements Pursuant to Section 392.461, RSMo. – Green Hills
Telephone Corporation**

Dear Mr. Woodruff:

Section 392.461, RSMo., allows Telecommunications Companies, upon notice to the Missouri Public Service Commission (“Commission”) to elect to be exempt from certain tariff filing requirements, including the tariffing of rates for retail telecommunications services provided to end-user customers. Accordingly, Green Hills Telephone Corporation hereby provides notice of its election to be exempt from tariff filing requirements and of its intent to withdraw the retail rates for residential and business packaged services from its tariff effective January 1, 2016.

In furtherance of this election, Green Hills Telephone Corporation is filing the following revised tariff sheets to withdraw the rates for its packaged services:

- Section 2, Fifth Revised Sheet 60.1, Cancelling Fourth Revised Sheet 60.1
- Section 2, Fourth Revised Sheet 60.2, Cancelling Third Revised Sheet 60.2
- Section 2, Third Revised Sheet 60.3, Cancelling Second Revised Sheet 60.3


