Accompanying this letter for filing via the Commission's Electronic Filing and Information System ("EFIS") are new tariff sheets – designated as P.S.C. MO. No. 9, which cancel Spire Missouri East P.S.C. MO. No. 7 tariffs and Spire Missouri West P.S.C. MO. No. 8 tariffs. These new tariffs are designed to increase Spire Missouri's aggregate annual gross base rate revenues by \$72.2 million, (\$24.9 million incremental and \$47.3 million already being collected through ISRS), as supported by the Commission's November 12, 2021 Amended Report and Order ("the Amended Order"). This represents an approximately 2.8% bill increase (or \$1.72 a month) for the average Spire Missouri customer. The bill impact could be higher or lower depending on a customer's service territory. The new tariffs also reflect the Company's further movement towards one Spire Missouri as tariffs for both operating units are now within the same tariff book.

Please note that the Company filed these tariffs as soon as practical after issuance of the Amended Order. The Amended Order changed the revenue requirement and most of the tariff rates.. The Company appreciates Staff's quick response in reviewing the tariffs and responding to questions from the Company. The Company has been working with all parties on tariff revisions and edits to ensure compliance with the Amended Order and the Stipulations and Agreements approved in this case and will continue to do so.

The accompanying tariff sheets issued by Spire Missouri are transmitted to you for filing as P.S.C. MO. No. 9, Schedule of Rates and Charges Applying to Spire Missouri Service Areas and Spire Missouri Rules and Regulations.
