ORDER RECOGNIZING CORPORATE NAME CHANGE
AND APPROVING TARIFF SHEETS

Syllabus: This order recognizes Budget Phone, Inc's name change to Budget PrePay, Inc., d/b/a Budget Phone, and approves the tariff adoption notices and revised tariff title page.

On April 20, 2007, Budget Phone, Inc., advised the Commission that it had changed its name to Budget PrePay Inc., d/b/a Budget Phone. Budget Phone filed adoption notices and a revised tariff title page, effective May 20, 2007.

On May 7, Staff filed its Recommendation. Staff stated that Budget Phone has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the accompanying adoption notices and revised tariff title page.

The Commission has reviewed the application, finds that it substantially complies with Commission Rules 4 CSR 240-2.060(5) and 4 CSR 240-3.545(20), and finds that it should recognize the name change. The Commission will also approve the adoption notices and revised tariff title page.

IT IS ORDERED THAT:

1. The Commission recognizes Budget Phone, Inc.'s name change to Budget PrePay, Inc., d/b/a Budget Phone.

2. The Commission approves the revised tariff sheets filed on April 20, 2007. Those tariff sheets were assigned tariff file number YX-2007-0760, YC-2007-0761, and YX-2007-0762, and are approved for service on and after May 20, 2007. The tariff sheets approved are:
